


### **ACF's Origin Story**

Asia Community Foundation (ACF) is a Singapore-based charity focused on promoting purposeful giving in Asia, and is the city's first Asia-focused, independent community foundation.

Founded by a group of experienced philanthropists from Asia Philanthropy Circle, ACF was born out of the pressing need for a regional platform to enable informed and effective cross-border giving and to address the various pain points and administrative burdens that donors experience.

Officially launched in 2023, ACF works with donors to support individual giving through donor-advised funds and advisory support as well as collaborative giving through pooled impact funds. Our aim is to catalyse funding and unlock greater potential for giving to address some of the most pressing social and environmental challenges facing Asia and the world today.

**202**2 marked the beginnings of Asia Community Foundation (ACF) as Singapore's first independent community foundation, founded by philanthropists for philanthropists. By March 2023, we had opened our first Donor-Advised Fund with a commitment of SGD \$1 million, and shortly thereafter, disbursed our first grant.

At ACF, our mission is clear: to simplify and amplify giving in the region. With so many organisations doing meaningful and impactful work, we are here to ensure their efforts continue and thrive. We aim to break down barriers for donors keen to give to the region while building a stronger ecosystem by collaborating with social organisations to understand the challenges they address and help strengthen their efforts. Though ACF is young, we are not inexperienced. Our team brings over 50 years of philanthropic and grantmaking expertise. We are built on the foundation of our sister organization, Asia Philanthropy Circle (APC), with its extensive network spanning 13 markets. Our growing portfolio includes 130+ regional nonprofits, and we are expanding both this network and our



community of donors. Whether you are a seasoned giver or exploring philanthropy for the first time, ACF offers a space to learn and grow together. By developing techenabled platforms and rolling out thematic impact funds championed by experienced donors, we aim to foster collaborative giving and create greater collective impact.

The journey ahead is full of opportunities to deepen learning, expand giving, and address pressing regional issues. While much work remains, together we can make it happen. Join us as we create a thriving Asia for all.





The PTIS allows Qualifying Donors approved by the MAS to receive a 100% deduction when making an overseas donation through a Qualifying Local Intermediary (QLI).

The well-attended informative session covered practical implications and tips to qualify for the scheme, and also provided a space for attendees to clarify any questions they had regarding the PTIS.




#### Bridging the Impact and Business Worlds

## **Role of the Governing Board**

The Board of Directors takes overall responsibility for the strategic direction and work of the organisation. The Board is responsible for the governance of ACF. It ensures that ACF is effectively and properly run and meets its overall purposes as set out in its constitution. Board meetings are held quarterly, where the Directors meet to take collective action to help ACF achieve its mission and vision.

## The responsibilities of the board include:

- Furthering ACF's overall purpose by setting its direction and strategy and monitoring its progress.
- Ensuring the work of the charity is effective, responsible and legally-compliant.
- Monitoring ACF's income and expenditure, and ensuring resources are used solely to further ACF's objectives and that ACF is financially sustainable.
- Being accountable to funders, donors, partners and regulators.
- Ensuring that ACF is appropriately staffed to carry out the work of the organisation.
- Ensuring Board and organisational effectiveness.

To enable governance succession planning and development, Board members of ACF have a term limit of 10 years. The Board Chair has a term limit of six consecutive years, and the Chair of the Finance Committee has a term limit of four consecutive years.

#### **Anti-Coruption**

We are committed to operating on a foundation of integrity, transparency and honesty. We periodically review and are working towards improving our processes continuously to prevent direct or indirect bribery, in order to safeguard and uphold our values.

ACF takes into consideration the possible consequences that Money Laundering and Terrorist Financing may have on the integrity and stability of the financial and philanthropic sector. We take preventive measures to combat activities by maintaining high financial transparency through proper accounting and internal control procedures, and maintaining good administrative, managerial and policy controls over our operations.

Donors wishing to give through ACF-adminstered philanthropic funds are required to first clear ACF's Know-Your-Donor compliance checks. Similarly, our social impact partners go through our Know-Your-Grantee screening process before they are eligible to receive grants from ACF.

#### Anti-Money Laundering and Terrorism Financing

#### **Conflict of Interest**

#### ACF has in place policies and procedures to manage and avoid situations of conflict of interest. All Board and committee members are required to make declarations of conflict of interest to ACF at the start of their terms, annually, and as soon as such conflict or the possibility of such conflict arises. Conflicted individuals may participate in discussions but do not vote or engage in any form of decision-making on matters where they have a conflict of interest. All employees are also required to make declarations of adherence to ACF's conflict of interest policies, which include declarations to be made as soon as the possibility of such conflict arises to ensure that all parties will act in the best interests of ACF.

## Environment and Sustainability

ACF aims to reduce the direct and indirect impact that we have on the environment and strives to set an example in the promotion of sustainable business practices and the protection of the environment. We understand sustainability and sustainable development as 'development that meets the needs of current generations without compromising the ability of future generations to meet their own needs'.<sup>1</sup>ACF works towards these objectives through the adoption and implementation of appropriate procurement policies, as well as ethical and sustainable practices in the daily operation of our organisation, such as in office management, travel, and the planning and execution of programmes and events.

## Data Protection & Cybersecurity

#### Whistle-Blowing

ACF collects personal data only when entrusted with such data provided by stakeholders. This personal data is not used for purposes other than what has been informed, or which are permitted under local laws and regulations. ACF will retain personal data only as necessary for any business or legal purposes, or with the data owner's consent. All electronic storage and transmission of personal data is secured with appropriate security technologies.

ACF is keenly aware of the threats of cyberattacks on its operations and the data that it holds. We adopt and implement cybersecurity standards in a 3-step framework of secure; respond; and recover. We strive to ensure the protection of all data, including personal data stored within our physical and electronic records, in order to uphold the safety of stakeholders whose data is entrusted to us, as well as to mitigate against disruption to our operations and activities caused by potential cyber-attacks.

Feedback can relate to donors, clients, partners, team members, or any of our stakeholders. Our communication channels are open, and we are committed to responding to all feedback in a timely and accountable manner. ACF is committed to improve our processes and policies where needed to help us improve our impact, culture and working practices.

#### Fundraising

Given that the administration of philanthropic funds is one of our core activities, ACF takes concerted steps to ensure that it complies at all times with fundraising regulations in Singapore, including regulations on fundraising for foreign charitable purposes. ACF will occasionally conduct fundraising activities and accept grant funding from funders and foundations for its own internal operations and overheads. ACF does not conduct any public fundraising, except if at all, for its own internal operations, and either through online fundraising platforms which subscribe to the Singapore Code of Practice for Online Charitable Fund-Raising Appeals, or with the necessary disclosures or permits as may be required. Fundraising for overseas entities supported or requested by donors/clients are done in compliance with guidelines and reporting as may be required by the Charities Unit.

#### **Reserves Policy**

The charity has a reserve policy for long-term stability of the operations and it ensures that there are sufficient resources to support the charity in the event of unforeseen circumstances. ACF aims to have two years of operational expenditure kept as reserves. The reserve level is reviewed yearly by the Board to ensure that the reserves are adequate to fulfil the charity's continuing obligations.
